Mr. Kimmelman is co-author of two books: *Advanced Chapter 11 Practice*, ICLE (2002), and *New Jersey Bankruptcy Manual*, ICLE (1983). He has also written several articles on bankruptcy topics and is a frequent lecturer on advanced bankruptcy issues.
