# SIGNATURES ON ELECTRONICALLY FILED DOCUMENTS

Pursuant to D.N.J LBR 5005-1, Appendix - Administrative Procedures for Filing, Signing and Verifying Documents by Electronic Means, Section II.C.1, filing any document using a login and password issued by the Court, shall constitute the Participant's signature for purposes of signing the document under Fed. R. Bankr. P. 9011. The name of the Participant under whose login and password the document is submitted must be displayed by an "/s/" and typed in the space where the signature would otherwise appear, e.g., "/s/Jane Doe."

The court will notify user if the signature on a document does not match the Participant. When this occurs, the document must be refiled with the Participant's signature.

### **INCREASE IN FILING FEES EFFECTIVE JUNE 1, 2014**

At its March 2014 session, the Judicial Conference of the United States Courts approved the following amendments to the Bankruptcy Court Miscellaneous Fee Schedule, which go into effect June 1, 2014.

- Increase to \$350 the fee to file an adversary proceeding
- Increase to \$75 the administrative fee included in the initial filing fee for Chapters 7, 12 and 13 cases, and increase to \$550 the administrative fee included in the initial filing fee for Chapters 9, 11 and 15 cases.
- The new Administrative Fee structure will be applied to the fee to split a bankruptcy case.

As a result of the changes the following fees will increase:

- Chapter 7 Petition \$335
- Chapter 9 Petition \$1,717
- Chapter 11 Petition \$1,717

- Chapter 12 Petition \$275
- Chapter 13 Petition \$310
- Chapter 15 Petition \$1,717

- Motion to Split Chapter 7 Case \$335
- Motion to Split Chapter 11 Case \$1,717
- Motion to Split Chapter 12 Case \$275
- Motion to Split Chapter 13 Case \$310
- Adversary Proceeding \$350

#### **NEW CHAPTER 13 FORMS AVAILABLE**

Two new local recommended forms have been approved by the Board of Judges:

- Application to Cancel or Discharge Mortgage/Lien
- Chapter 13 Order Authorizing Cancellation, Voiding and/or Discharge of Record of Mortgage/Lien

When completing the Application, the debtor or debtor's attorney must include a hearing date that will be used in the event an objection is filed. The date should be at least 21 days from the filed date of the application. Hearing dates for all judges are available on the Court's web site.

A new event has been created for efilers to use when filing the application:

[Application to] Cancel or Discharge Mortgage/Lien located in the Motions/Applications category.

#### **MEDIATION**

Pursuant to the Court's *General Order Adopting Mediation Program Pending Adoption and Amendment of Local Rules*, dated November 20, 2013, the Board of Judges has approved a comprehensive, court-supervised mediation program to facilitate resolution of contested matters and adversary proceedings for debtors, creditors and parties in interest.

# PRESUMPTIVE REFERRAL TO MEDIATION IS EFFECTIVE IMMEDIATELY IN ADVERSARY PROCEEDINGS FILED ON OR AFTER MAY 1, 2014

Three new mediation forms have been approved by the Board of Judges, and are available on the Court's web site:

- Mediation Report, located in the Misc. Events category (Bankruptcy or Adversary)

## **Bounced Back Emails**

One of the most frequent problems encountered by our help desk staff is an efiler's failure to update their user account when their contact information changes. It is important that all efilers review their contact information periodically, and update it when necessary. As outlined in the Court's Notices to the Bar, dated November 19, 2007 and January 3, 2008, our Court no longer sends paper BNC notices to efilers (with the exception of the Meeting of Creditors notice). As a result, failure to timely update contact information will prevent efilers from receiving notices sent by the Court pursuant to Fed.R.Bankr.P 2002. PLEASE NOTE: Email accounts must be of sufficient capacity and should be monitored periodically to prevent transmission problems.
