

Events Affected By CM/ECF v 3.1

Many of the changes to CM/ECF in version 3.1 are a result of provisions of BAPCPA. Specifically, the Act requires the court to collect various statistics, effective October 20, 2006. In addition to BAPCPA, the Judicial Conference of the United States and the Administrative Office of the United States Courts also require the court to collect statistics. To compile the information accurately the following pleadings must be e-filed using the event indicated. If the correct event is not used to file the pleading e-filers will receive an email from the court indicating that the pleading must be refiled using the correct event.

The Summary of Schedules screen will display depending upon the schedule(s) selected. The information in the fields will need to be updated if changed via the filing of an amended schedule.</p> <p>Fees: If schedules D/E/F are being filed, the user will be prompted to answer: Is a previously listed creditor’s address being amended or Is an attorney being added for a previously listed creditor? If the user is amending Schedules D/E/F and answers YES to either question no fee is due.</p> <p>NOTE: There is still an event entitled Amended List of Creditors.</p>
