
**STANDING ORDER**

**WHEREAS**, the Bankruptcy Court Schedule of Fees issued in accordance with 28 U.S.C. section 1930(b) provides that the Court may exempt persons or classes of persons from a fee for electronic access to Court data,

This Court has determined that the waiver of said fees for any non-profit legal aid or non-profit legal services agency located in New Jersey would avoid unreasonable burdens and would promote public access to Court data.

Therefore, **IT IS ORDERED** that non-profit legal aid or non-profit legal services agencies located in New Jersey be granted an exemption from fees for electronic access to court data. Exhibit A of this Order contains an updated listing of the exempted agencies, superceding a previous Standing Order of this Court entered on January 2, 2001.
