This position is located in the Bankruptcy Court clerk's office. The chosen candidate will assist in the development of the Next Generation Case Management and Electronic Case Files system (CM/ECF). In this position the candidate will be expected to modify and develop source code using Java/J2EE. The inventory of tools used to maintain the existing CM/ECF and to develop the Next Generation of CM/ECF are Java, JavaServer Faces (JSF v 2.0 or above), PrimeFaces and Web Services. The candidate will also create custom applications to be used internally by the court. We are looking for developers that have the ability to be productive immediately and work in a team environment. Strong communications skills, both oral and written are required. This position is classified as one year/one day position with benefits.

Skills/Abilities:

- Must be able to work independently and have good writing and communications skills.

Required experience with the following:

- Java/J2EE
- JSF (v 2.0 or above)
- PrimeFaces (preferred, similar software such as RichFaces or IceFaces will be considered)

Preferred experience with the following:

- Web Services (ability to create RESTful Web Services; bonus: JAX-B and JPA)

- NIEM (National Information Exchange Model)
- Linux operating systems

A college degree in Computer Science, Public Administration or Business is required. A Masters Degree a plus. Must possess a minimum of two years of specialized experience.

For placement above the minimum entry level, at least two years of specialized experience must be or equivalent to the next lower CL level in Federal Service.

Appointment to this position is provisional contingent upon a background record check, including fingerprinting and other possible investigation. The retention depends upon a favorable suitability determination after the 10-year background investigation. The initial investigation will be updated every five years thereafter.
