**ORDER ADOPTING AMENDMENTS TO LOCAL RULES
AND PROPOSED LOCAL RULES**

This Court being vested with authority pursuant to 28 USC section 2071, Rule 83 of the Federal Rules of Civil Procedure, and Rule 9020 of the Federal Rules of Bankruptcy Procedure to make and amend local rules; and a proposal to amend local rules and adopt proposed local rules having been submitted to the Board of Judges for review at its March 20, 2003 Judges' meeting, pursuant to the Local Rules Annual Rule Making Cycle, as published in January of 2003;

IT IS ORDERED that:

1. The captioned proposed amendments to the District of New Jersey Local Bankruptcy Rules, and proposed District of New Jersey Local Bankruptcy Rules (annexed as Exhibit A) are hereby approved, pending approval of same by the United States District Court for the District of New Jersey;
2. The Bankruptcy Court shall immediately and prominently publish a Notice to the Bar regarding the proposed Local Rule amendments and proposed Local Rules in legal journals and on the Court's Web Site: www.njb.uscourts.gov;
3. The amendment of Local Rules and proposed Local Rules are to be published in the manner prescribed above for a 30 day comment period, after such time, an Order seeking District Court approval of same will be submitted to the District Court in time for its June 19, 2003 Judges' meeting;

4. The amendments and proposed Local Rules shall become effective as of the date of signature on the District Court Order.
