## Minutes of Lawyers Advisory Committee Meeting

Quorum: Chair Catherine Youngman reported the existence of a quorum to conduct business.

- Welcome and Administrative Update Chair Catherine Youngman honored the recently departed William Mackin, former Chair of the Lawyers Advisory Committee, paying tribute to his service to the LAC, his commitment to the bar and his legacy as a friend and member of the community. The Chair then advised that the Minutes from the June 21, 2017 minutes had been reviewed, approved, and posted to the Bankruptcy Court's website.
- II. Commercial Bankruptcy/Chapter 11 Subcommittee Report Morris Bauer, Chair (absent), submitted a written report discussing various issues being worked on by the subcommittee, specifically the Chapter 11 combined plan and disclosure statement.
- III. Consumer Bankruptcy Subcommittee Report Andrew Finberg, Chair, reported on three (3) issues being worked on by the subcommittee. First, whether or not secured lenders and/or servicers should be required to submit and file signed final loan modification papers when they are actively participating in the loss mitigation program. Second, whether HELOC lenders should be required to send payment change notices directly to borrowers and counsel every six months. Third, the Chapter 13 proposed fee guidelines currently being reviewed by the Board of Judges.
- IV. Local Rules Subcommittee Chair, Kim Lynch reported that the Subcommittee was primarily working on a potential rule to accompany the recently approved order reinstating case.
- V. **Local Forms Subcommittee** Shoshana Schiff, Chair, reported on the completion of the standard form loan modification order. A motion to approve the form of order was proposed and seconded, and the Lawyers Advisory Committee moved to send the proposed form of order to the Board of Judges. The subcommittee chair also reported

- on suggested changes to the Local Form 16a, dealing with a potential revision of the post-petition payment history attached to motions for relief from the automatic stay.
- VI. **Newsletter Subcommittee** Carrie Boyle, Chair, discussed the most recent publication of the Absolute Priority as well as her subcommittee's work in preparing for the next issue.
- VII. **Board of Judges Update** Honorable Christine M. Gravelle, USBJ (absent). Chief Judge Kathryn Ferguson, USBJ presented in place of Judge Gravelle, and discussed further the addition of recent forms to the Bankruptcy Court's website. The Chief Judge requested that the LAC obtain feedback from the bar regarding the implementation of the new forms.
